As SMA continues to steal away aspects of his mobility, David must rely on assistance for many of the tasks of basic living, including dressing, bathing, cooking, and chores. Using a power wheelchair to get around, he's limited in his options outside of home: no standard vehicle can accommodate his power chair, and public transportation is unreliable or downright unsafe.

David has already had a chance to drive an accessible vehicle, which means he's ready to enhance his life with greater mobility and independence. For needs ranging from staying employed to getting to church, a wheelchair van will be a gamechanger for the gamer and student.
